- Summer Training Academy for Research Success (STARS)
- Tribal Membership Initiative (TMI)

In the past, the Graduate Division covered this expense. The Graduate Division will continue to cover the fellowship stipend, tuition and fees; however, NRST will be funded by the graduate program. The student's program may provide NRST from GSGEI or some other discretionary fund source. Please note that 90% of NRST paid by the program on behalf of a SDF, CR, SEED, STARS, or TMI fellow will be returned to the program by the EVCAA via the GSGEI allocation.
