In August 2021, the Academic Senate sent out a notice regarding the Educational Policy Committee (EPC), the Graduate Council (GC), and the Undergraduate Council (UGC) updates to the proposal guidelines to establish new graduate degree programs, establish new undergraduate majors and minors, and make changes to existing undergraduate majors and minors. For departments and programs that plan to submit proposals, we ask that you follow these revised guidelines. More details are provided below.
